

## SAG™ 2226 Antifoam

### Product Description

SAG 2226 antifoam is an antifoam compound concentrate formulated without silicone polymers.

### Storage and Shelf Life

The product should be stored under cool and dry conditions. When stored at below 32 °C, SAG 2226 antifoam has a shelf life of 12 months from the date of manufacture. The product may become hazy or separate if stored under cold conditions. Normal appearance returns when warmed slightly.

### Potential Applications

SAG 2226 antifoam was developed for use as a foam control agent for industrial and some specific food contact applications.

### General Considerations for Use

This will depend on the type of formulation in which SAG 2226 antifoam is being included and the other ingredients involved. Maximum efficiency may be achieved by mixing 1-part of SAG 2226 antifoam with 9-parts of organic oil with gentle stirring.

### Toxicity

SAG 2226 antifoam is basically non-hazardous with a very low order of toxicity, although prolonged contact with the skin or contact with the eyes may cause some irritation. See our health and safety data sheet for more information.
